### INVESTMENT COMMITTEE MEETING MINUTES

## January 25, 2022

The Investment Committee met via video conference at 8:30 a.m. on January 25, 2022. Present via video conference were Committee members Arturo F. Agra, Chair, Suzanne B. Grant, A. The Committee joined Mr. Agra in thanking Ms. Johnson, who is retiring from the Delaware Department of Justice, for all her years of service to the Committee, the System and the State.

On the motion of Mr. Stalnecker, and seconded by Ms. Stratton, the Committee, under its authority to execute documents relating to partnerships over which it exercises authority, voted to approve an amendment to the Limited Partnership Agreement for Summit Partners Private Equity Fund VII-A, L.P., subject to legal review of the documents.

On the motion of Ms. Grant, and seconded by Ms. Stratton, the Committee voted to commit up to \$40 million to Marcus Partners Fund IV, L.P. subject to legal review of the documents.

There being no further business to come before the Committee, the meeting was, on the motion of Mr. Stalnecker, seconded by Ms. Shevock and unanimously approved, adjourned at 11:46 a.m.
