On the motion of Ms. Stratton, and seconded by Ms. Shevock, the Committee voted unanimously to recommend that the Board approve a commitment of up to \$30 million to SDC Digital Infrastructure Opportunity Fund IV, L.P., subject to legal review.

There being no further business to come before the Committee, the meeting was, on the motion of Mr. Hinkley, seconded by Ms. Stratton and unanimously approved, adjourned at 10:59 a.m.
