6. Minutes of the January 8th, 2013 PAC meeting:

Charlotte Lister moved to approve the minutes. Nancy Patterson seconded the motion. The motion passed.

7. Chairmans Report:

The Fund's diversified portfolio may have only returned 2.0% in fiscal 2012, but has compounded out at 13.2% per year over the last three fiscal years and 7.6% per year over the last ten years.

Total assets in the trust fund as of February 28^{th} , 2013 are \$7,941MM. The return of the trust fund for the month of February is 0.7% which is higher than the Delaware Benchmark. Fiscal year to date the trust fund is up 8.1%, however it is still 1.5% below the Delaware Benchmark.

8. Old Business:

On behalf of the Pension Advisory Council I have met with Representatives Melanie Smith, Jeff Spiegelman, and Senator Karen Peterson regarding Pension increases and O.P.E.B funding. They are all respectful of the needs for State Retirees; however the current state of the economy may prove it difficult to fulfill our needs.

HB 164 which permits employees who are employed in positions that are classified as Hazardous Duty Level A-1 to retire at 25 years without any reduction. This Bill was passed and signed but not enacted until a PLR (Private Letter Ruling) from the IRS on whether different groups in the same pension plan can have different benefits. The IRS refused to make a ruling based on the bill not meeting the criteria for the IRS to make a ruling. The IRS decision makes this current bill null and void.

9. New Business:

Joseph Malloy commented on the pension workshops and thier importance. He also sated his appreciation and gratitude of the PAC membership for its participation at the workshops. Full participation at these workshops shows our dedication to represent State Employees regarding retirement issues.

Kim Vincent commented on recent lower than expected turnout at the Brandywine School workshop on scheduled date of the workshop being so close to Good Friday. The Pension Advisory Council agreed.

SB 28 Bill allows a per diem employee of the legislature to receive a service pension while working for the legislature. This bill which is still in committee would allow per diem employees who work for legislators who already receive a pension to bypass current rules regarding break in service between pension covered positions as well as earning limits. James Harrison asked Kim Vincent if the bill passed would it open the door for other agencies to try to bypass current rules. Kim Vincent stated it a good possibility it could happen.

Kim Vincent stated the Pension Office is currently working on possibly changing the joint survivor benefits from 50 to 75 % to 100% for all plans. The Pension Office is computing the actuarial for the cost that would be involved if the change would happen.

Joseph Malloy stated he will meet with Senator McDowell and Marshall to discuss possible OPEB and PRI increases for FYI 2013.
