6. Approval of the May 8, 2018 Minutes:

Jim Testerman motioned to approve the minutes of May 8, 2018. The motion was seconded by Chuck Longfellow. The motion passed.

7. The Chairman's Report:

Assets in the Fund at the end of April totaled \$9,852.8 million. This represents a net increase of \$29.9 million during the month Estimated returns through April 30, 2018 are as follows.

8. Old Business:

David Taylor stated the organization he represents (DRSPA) will be asking the legislature for \$1000.00 PRI increase, no increases in health care and increase of \$3000.00 in the States retiree's death benefit. Jim Testerman made it aware that any lobbying needs to be done no later than May 21st. Mark up begins and any requests after that will have to wait until the next legislative year.

It was debated what the Council should pick if a choice was given to us. No PRI increase for FYI 19 and no increase in health care costs for FYI 19, and 20 or a PRI increase for FYI 19 and probable healthcare cost increase in FYI 20. The general consensus was to accept the PRI increase but no official vote was taken.

9. Legislative Update:

HB 179

This Act permits State employees who are employed by the Delaware State Police and work in a variety of job titles, all of which are more commonly referred to as "9-1-1 Operators," to retire at 25 years without any reduction. Those employees will pay a higher employee contribution rate than other State employees. (Senate Finance Committee)

SB 95

This bill establishes a 20 year retirement for correction officers and specified peace officers within the State Employees' Pension plan. The bill amends the multiplier prospectively for the calculation of pension benefits for correction officers and specified peace officers. For service prior to January 1, 2018 the multipliers of either 1.85%, 2.0% or 2.45% would continue to be in effect and then for years of service after January 1, 2018 a uniform multiplier of 2.5% for the first 20 years, plus 3.5% for years beyond 20 years. In addition, this bill amends the employee contribution for all correction officers and specified peace officers to a uniform 7%. (Assigned to Finance Committee in Senate no change) large cost to bill.

SB 7

This Act provides county and municipal police and firefighters with the same pension burial benefit that is provided to retired state employees effective July 1, 2016. This Act is named for Wilmington Firefighters Captain Christopher M. Leach, Lieutenant Jerry W. Fickes, and Lieutenant Ardythe D. Hope, who lost their lives fighting a house fire on September 24, 2016. (Out of Committee Senate no change) It was changed to line of duty death benefit.

SB 6

This Act increases the state employees' pension plan burial benefit from \$7,000 to \$10,000 effective July 1, 2016. This benefit has not been changed since July 2001. (Assigned to Senate Finance committee) No change possible cost issue.
