## 4. GOVERNANCE COMMITTEE REPORT

J. Adams reported that the Governance Committee met on November 9, 2023, and welcomed a new member, K. Simpler, to the Governance Committee. D. Stratton has agreed to serve as Chair of the Governance Committee upon the retirement of current chair, P. Tikellis. A resolution was presented to officially nominate D. Stratton to serve in this capacity.

S. Grant thanked D. Stratton for her continued support of the Delaware Public Employees' Retirement System.

**MOTION** was made by N. Shevock and seconded by A. Agra to approve D. Stratton to serve as the Chair of the Governance Committee.

## MOTION ADOPTED UNANIMOUSLY

J. Adams reported that the Governance Committee also reviewed the Fiscal Year 2023 Actuarial Valuation and the Judicial Summary Plan Description.

The next Governance Committee meeting is scheduled for February 22, 2024.

## 5. PENSION ADVISORY COUNCIL REPORT

The election of officers took place on November 7, 2023, at the Pension Advisory Council meeting. D. Taylor will remain as the Pension Advisory Council Chair with K. Crouse serving as the first Vice-Chair and J. VanderDecker serving as the second Vice-Chair.

## 6. STATE PENSION ADMINISTRATOR'S REPORT

#### **EMPLOYEE RECOGNITION**

J. Adams recognized the Benefits team for their completion of another successful Medicare Open Enrollment.

J. Adams recognized Investments and Accounting regarding their work on the FY23 Annual Comprehensive Financial Report (ACFR).

#### POSITIONS UPDATE

J. Adams reported that the HR Supervisor position in the Benefits section has been filled. The office is in the process of finalizing the Cash and Debt Manager II position with a qualified candidate and will hopefully have an announcement to share very soon. There were two Human Resource Analyst I positions, one of which is a limited term position, vacated by employees who sought promotional opportunities at other State agencies; the office is in the process of filling those positions now. The Administrative Specialist II position continues to await approval by the Department of Human Resources for reclassification.

#### COUNTY/MUNICIPAL NEW ENTITY RESOLUTIONS:

J. Adams reported that the City of Dover submitted a resolution requesting to participate in the County and Municipal General Pension Plan on or after January 1, 2024. The City of Dover also submitted a resolution requesting to allow firefighters to participate in the County and Municipal Police/Firefighter Pension Plan on or after October 9, 2023.

**MOTION** was made by A. Agra and seconded by H. Stafford to approve the City of Dover joining the County and Municipal General Pension Plan, effective January 1, 2024, and for the City of Dover firefighters joining the County and Municipal Police/Firefighter Pension Plan, effective October 9, 2023.

## MOTION ADOPTED UNANIMOUSLY

#### 7. DEPUTY ATTORNEY GENERAL REPORT

R. Connell reported that the Governance Committee approved the Board Code of Conduct, the Board Education Policy, and the DPERS Statement of Investment Objectives. There were no substantive changes worth reporting specifically.

**MOTION** was made by N. Shevock and seconded by A. Agra to approve the policies as recommended by the Governance Committee.

## MOTION ADOPTED UNANIMOUSLY

S. Tatman reported that a fully executed actuarial audit services contract is now in place. Buck Global, LLC will begin their work in mid-December.

## 8. INVESTMENT COMMITTEE REPORT

R. Gooderham reported that global equity and fixed income markets fell in October amid concerns over rising interest rates, persistent inflation and the Israel-Hamas conflict. US economic data released over the period continued to point to a tight labor market and strong consumer spending. The resilient data, along with hotter than expected inflation readings, weighed on market sentiment as investors increasingly expect a higher for longer interest rate environment. US equities, as measured by the broad Russell 3000 index, declined by 2.7% during the month. Within US equities, growth fared better than value stocks and small cap lagged. International equity underperformed US equities as the MSCI All-Country World ex-U.S. stock index declined by 4.1%. In fixed income markets, rising interest rates led to losses across most assets. The benchmark 10-year US Treasury yield briefly crossed 5% for the first time since 2007. For the month, the Bloomberg Universal bond index declined by 1.5% and the Bloomberg High Yield index fell by 1.2%.

R. Gooderham reported that DPERS Fund assets at Northern Trust were estimated to be \$12,708.5 million at October 31, 2023, representing a net decrease of \$282.3 million during the month. Estimated returns through October 31st, 2023, are as follows:

At the meeting, the Committee approved under its authority:

- An election request for Viking Global Opportunities Fund L.P., subject to legal review.
- To acquire up to 100% of available secondary interests in six Accel funds (Accel X, Accel Leaders, Accel Growth, Accel Growth II, Accel Growth III and Accel Growth IV) provided the total purchased value exceeds \$1 million and subject to transaction structure and legal review. Following the review, ultimate approval will be delegated to the Chair of the Investment Committee.

The next Investment Committee meeting is scheduled for Tuesday, December 12, 2023.

**MOTION** was made by H. Stafford and seconded by A. Agra to enter into a second Executive Session to consider pension personnel matters, confidential medical records, legal matters, sensitive commercial trade secrets, and confidential financial information.
