#### 4. AUDIT COMMITTEE REPORT

S. Tatman shared Maria Hurd is a Certified Public Accountant, Director of Accounting and Auditing, leads a team of specialized retirement plan auditors, and has retirement plan audit niche in benefits. Maria is highly regarded and respected in the industry. S. Grant added Maria has a Bachelor of Science degree in Accounting and International Management from Georgetown University, and an undergraduate degree from Wharton School of the University of Pennsylvania. #### 6. STATE PENSION ADMINISTRATOR'S REPORT

#### EMPLOYEE RECOGNITION

J. Adams announced Amanda Polley was selected as the 2025 William "Ray J" Johnson Award recipient for exemplary quality of work, work ethic, professionalism, willingness to assist coworkers and pensioners, desire for growth, training role with new employees, ability to identify and implement process improvements, and playing a crucial role in reaching an impressive milestone within her section. Amanda's patience, kindness, and helpfulness are consistently recognized in weekly reports – receiving kudos from coworkers and pensioners alike.

The Active and Retiree newsletters were shared with the Board. J. Adams recognized S. Tatman, who leads the team on creating the newsletters.

### POSITIONS UPDATE

J. Adams introduced A. Visalli, Deputy Director of Office of Management & Budget. The HR Supervisor position has posted and interviews are scheduled for March 12 and 13, 2025. Requests to fill the Information Systems Manager, two Limited Term HR Analyst I positions, and a Limited Term HRIS Analyst I position have been submitted. The Cash & Debt Manager and a HR Analyst I position

remain vacant.

# **ERP MODERNIZATION PROJECT:**

The ERP Modernization steering committee is scheduled to meet in March to finalize the software solution vendor. The preliminary contract and negotiation planning has begun. Computer Aid, Inc. ("CAI") recognizes and appreciates the exceptional efforts made by the Pension team in prioritizing and executing a thorough data cleanup. Typically, CAI encounters a significant amount of inaccurate data, which often surprises clients. However, the work the Pension team has completed to date is nothing short of impressive. The Independent Verification and Validation (IV&V) request for proposal is with Government Support Services for publishing in the near future.

#### LEGISLATIVE UPDATE:

Senate Amendment 1 for Senate Bill 42, adding magistrates, commissioners, and masters in chancery to the Judicial Pension Plan with an effective date of February 9, 2025 was signed by the Governor.

There is nothing new to report for the following legislation:

- House Bill 2, sponsored by Representative Carson, to increase the burial benefit from \$7,000 to \$8,000 and Senate Bill 31, sponsored by Senator Brown, to increase the burial benefit from \$7,000 to \$10,000 have been introduced.
- Senate Bill 52, sponsored by Senator Buckson, seeks to change the "return-to-work" restrictions for retirees who return to work for the State of Delaware. The key changes:
  - 1. Reduce the required bona fide separation from 6 months to 3 months;
  - 2. Reduce the bona fide separation requirement from age 65 to age 59 ½; and
  - 3. Eliminate the annual earnings limit.

#### 1. DEPUTY ATTORNEY GENERAL REPORT

B. Tate reported thirty-three proposals were received for the specialized legal services request for proposal. The Department of Justice is reviewing the proposals and will present them to the Board of Pensions Trustees at the next meeting.

#### 2. INVESTMENT COMMITTEE REPORT

DPERS Fund assets at Northern Trust were estimated to be \$15,382.1 million at January 31, 2025, representing a net increase of \$370.9 million during the month. Estimated Gross returns through January 31, 2025, are as follows:

- A schedule change to the investment management agreement with Wellington Dividend Growth, subject to legal review.
- To withdraw \$150 million from the BlackRock Aggregate Index Fund and transfer it to the T. Rowe Price Floating Rate Bank Loans account.

The next meeting of the Committee is scheduled for Tuesday, March 18, 2025.

**MOTION** was made by N. Shevock and seconded by B. Maxwell to enter into Executive Session to consider pension personnel matters, confidential medical records, legal matters, sensitive commercial trade secrets, and confidential financial information.
